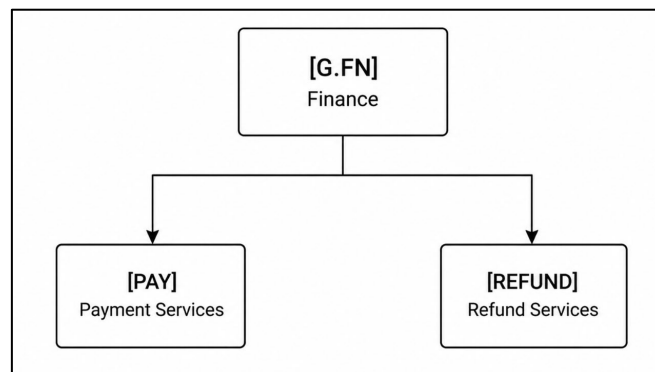


Figure 1: Functional Diagram (for public users)

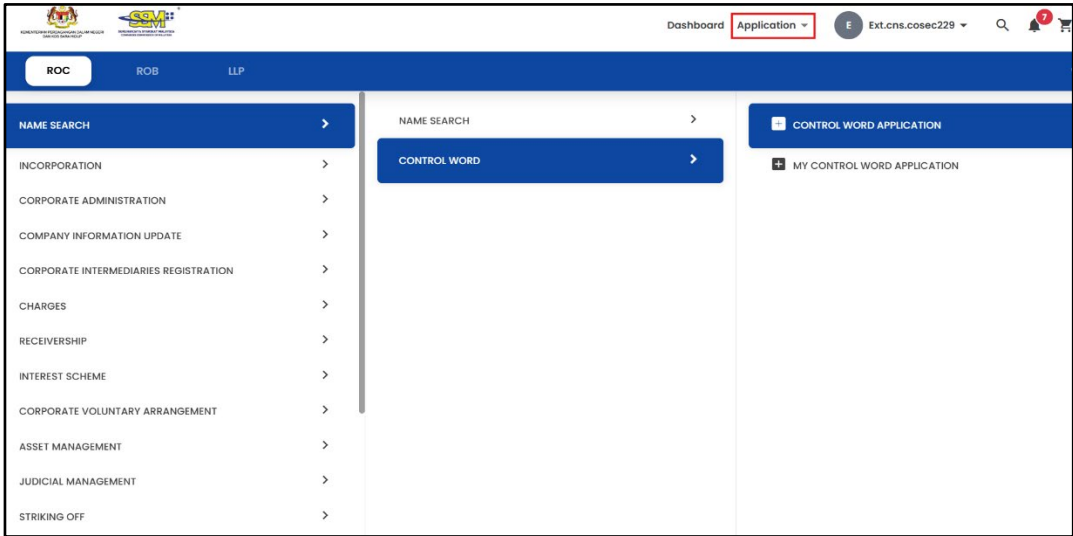
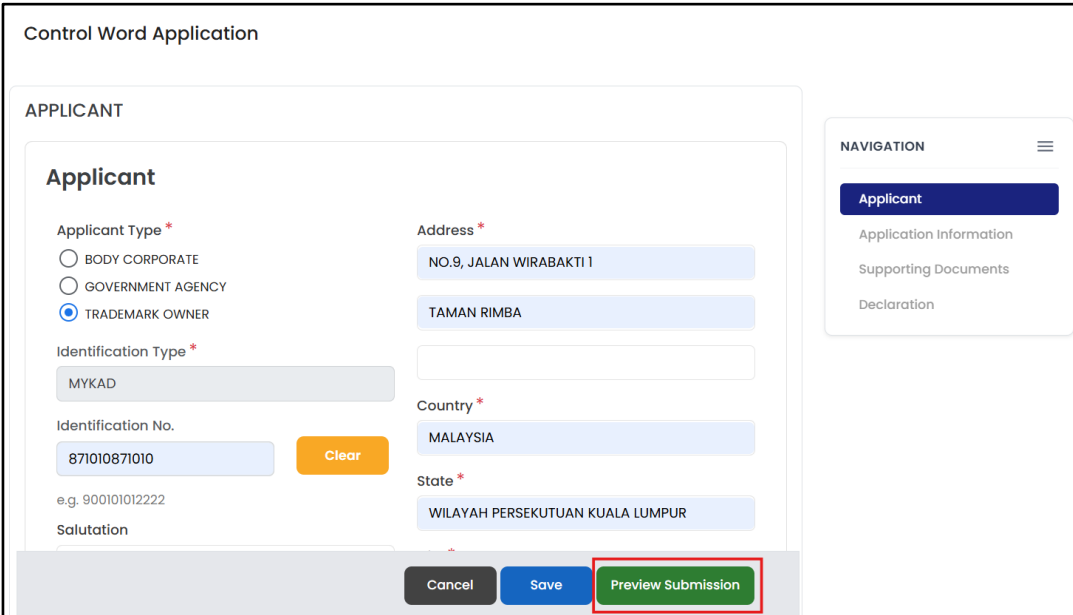
User Role

2.	Complete the application form, then click Preview Submission to continue. 

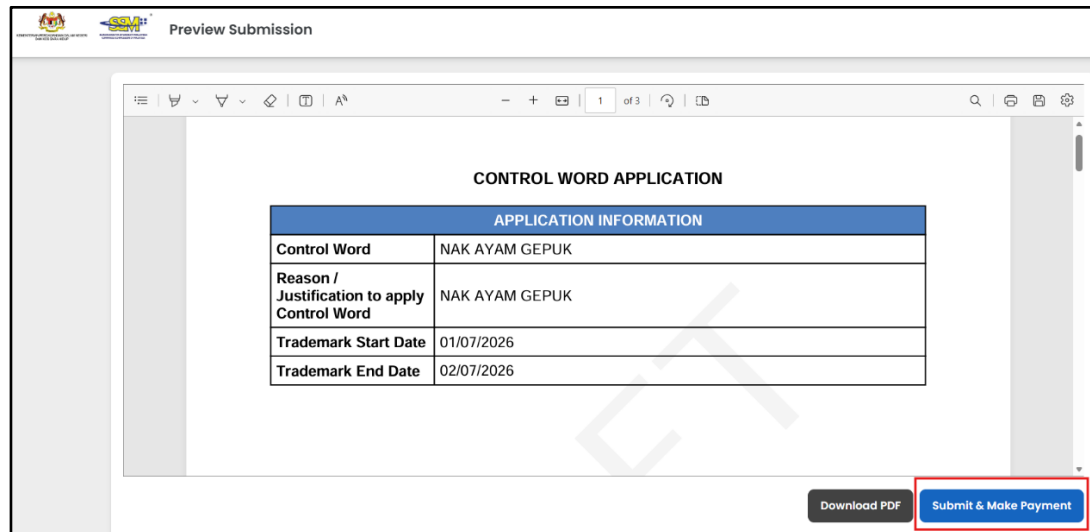

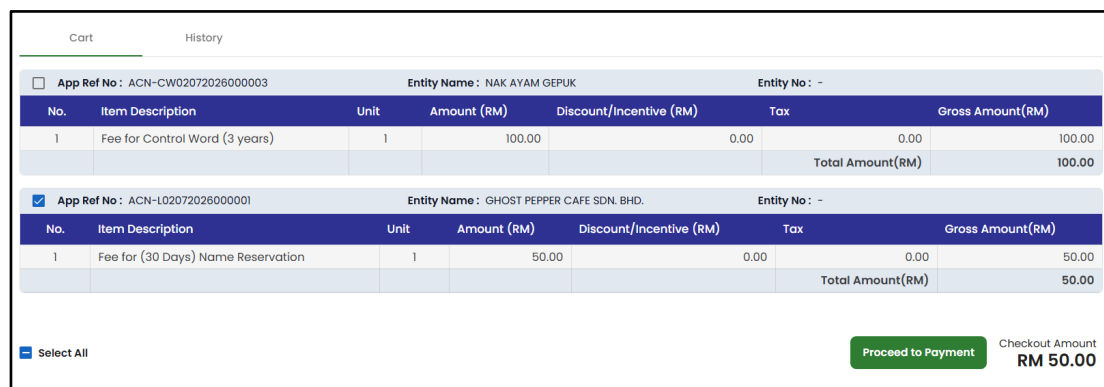

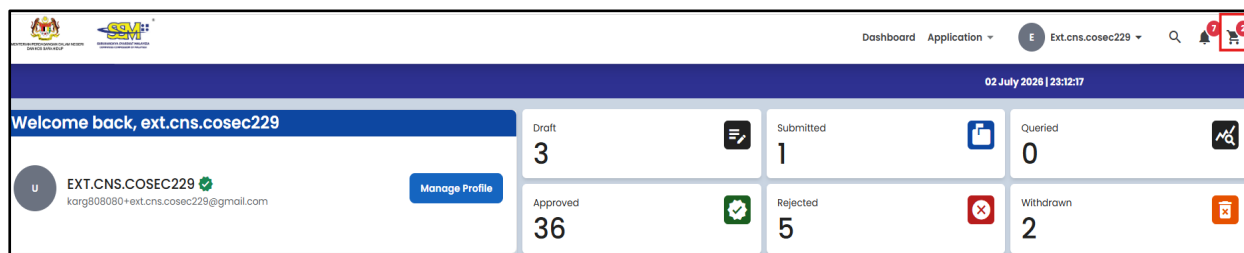

The **Payment Cart** screen displays all submissions that are ready for payment. Upon accessing this screen, the application status will automatically update to **Pending Payment** in your task list.

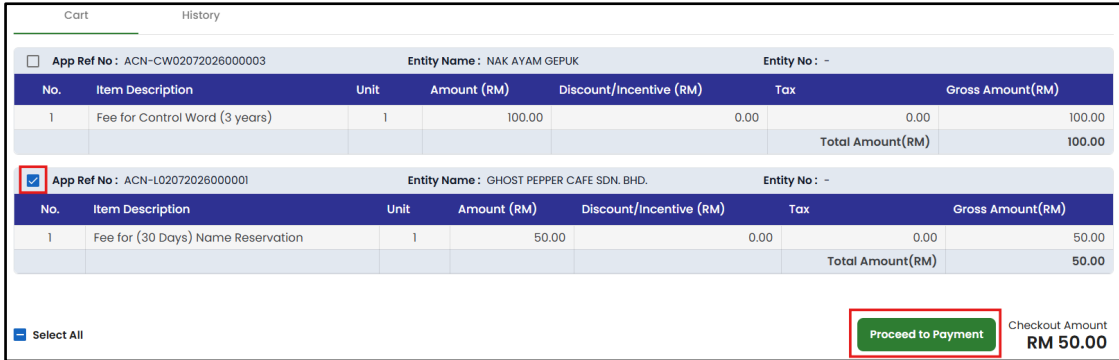
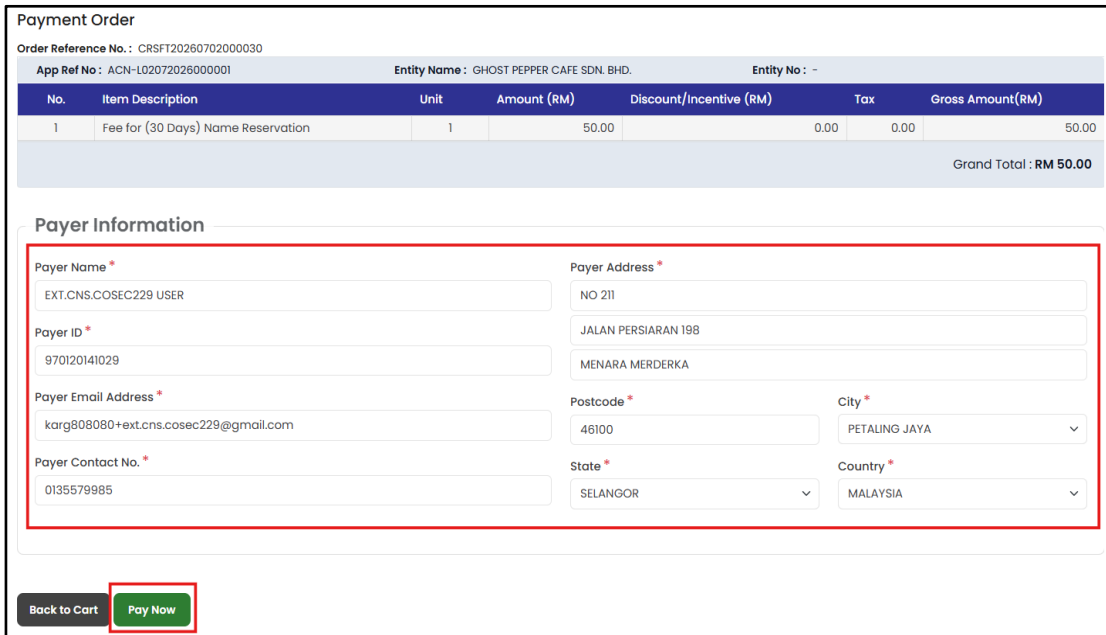

2.	The system will display the Payment Order screen containing the Payment Details and Payer Information sections. The fields are auto-populated based on your profile but remain fully editable. Note: All information fields are mandatory.  Review your details and click the Pay Now button.

3.	Upon clicking Pay Now, you will be redirected to the secure external SSM Payment Gateway screen. Please follow the external on-screen instructions to authorise your payment.  Please wait while we redirecting you to SSM Payment Gateway...
4.	Once the payment transaction is processed by the gateway, you will be redirected back to the CRS system, where one of the following scenarios will occur: a. Payment Successful (refer to section 4.2.3) b. Payment Failed (refer to section 4.2.4)

3.2.3 Payment Successful

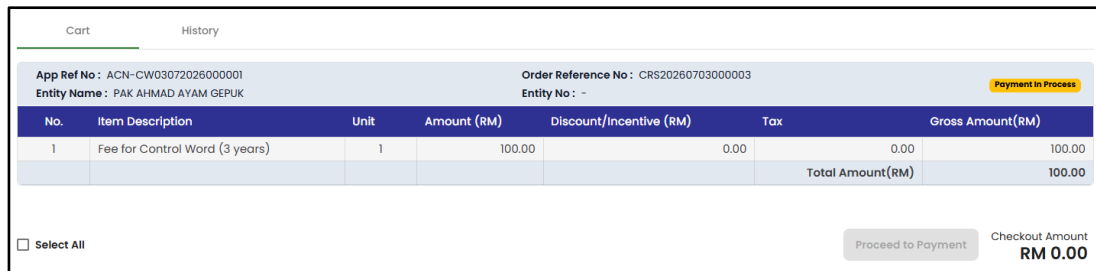
Field Num.	Description
1.	Upon a successful transaction, the Payment Complete screen will be displayed and a confirmation email will automatically be sent to your registered email address. 
2.	You can view the receipt in Payment History. Refer to section 4.2.5 Payment History.

3.2.4 Payment Failed

Field Num.	Description
1.	If the transaction fails (e.g., timeout, insufficient funds or cancelled by the user), the Payment Failed screen will be displayed. 💡 What to do next: Your application will remain safely stored in your Payment Cart. Proceed to Step 2 to re-attempt the payment before the Expiry Date has passed. 
2.	To re-attempt the payment, click the Cart icon in the top-right corner of the screen. 

3. The **Payment Cart** screen will be displayed.

Note: If a "**Payment in Process**" status is displayed, the system is still verifying the previous attempt with the bank. Please wait approximately **30 minutes** before trying again.



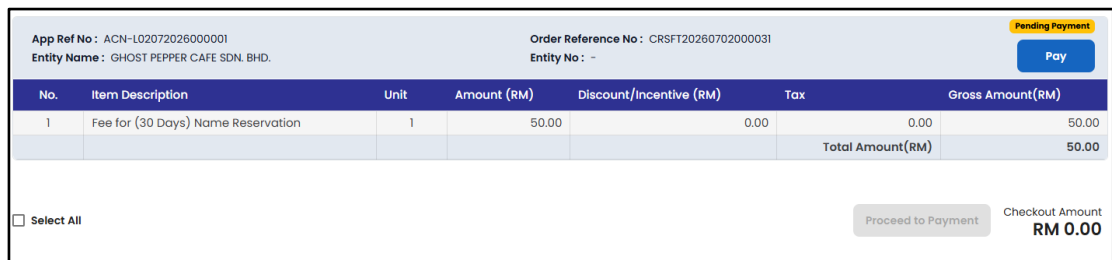
