1. Introduction

1.1 Purpose of Document

This manual provides comprehensive guidance on using the **Insolvency - Striking Off** module in CRS – HT4. It is intended for registry officers, back-office staff and authorized public users who perform company name checks, pre-approvals and validations as part of company registration workflows.

The manual covers the functional overview, user roles, navigation, search procedures, evaluation criteria and decision workflows. All instructions assume that users have valid CRS – HT4 credentials and appropriate permissions.

1.1.1 Prerequisite

A registered external **company secretary** (EXT-COSEC) who is active in **SSM4U**, has been verified and hold a valid SSM Practising Certificate for the entity.

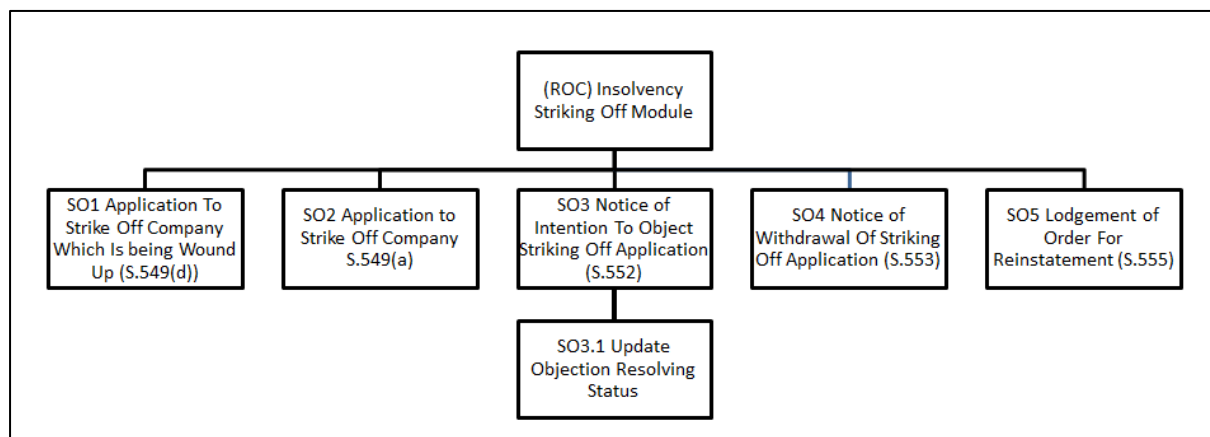
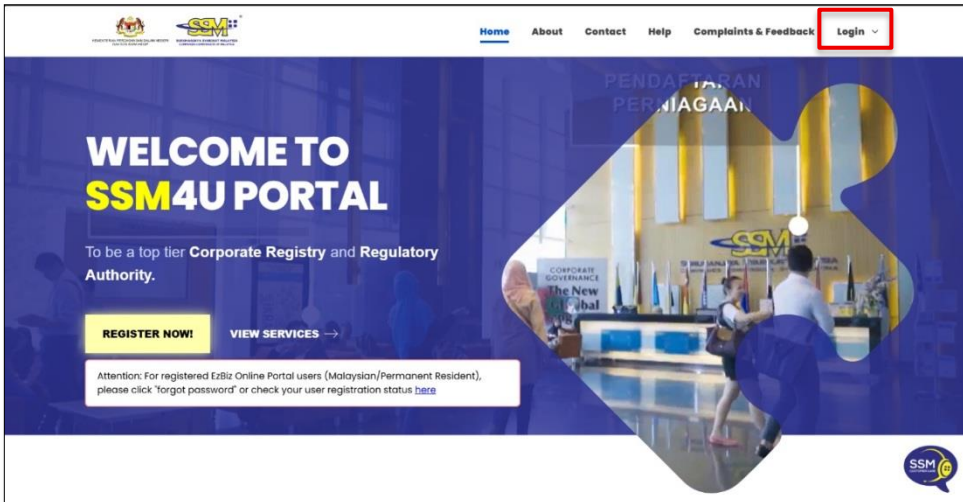
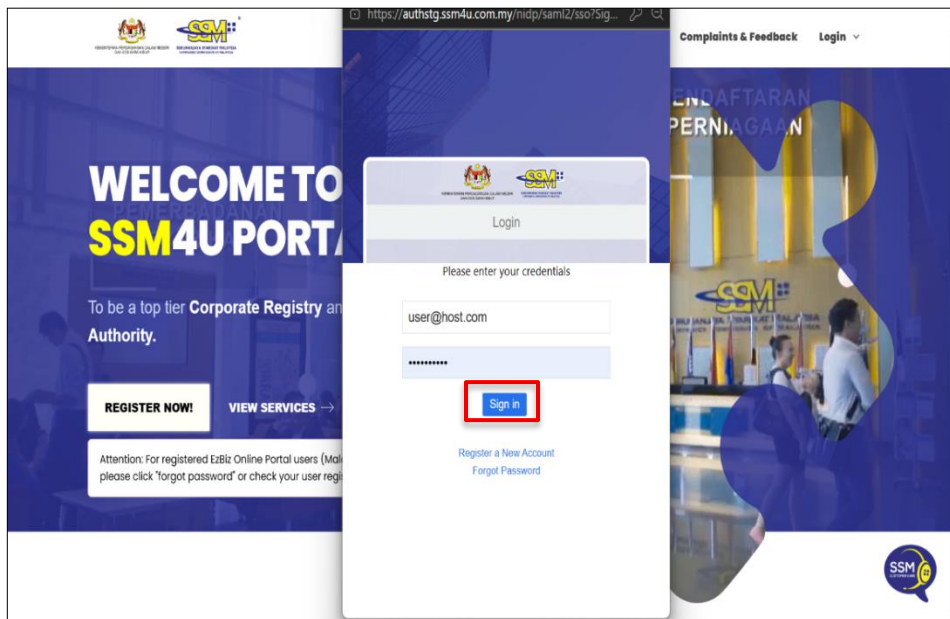


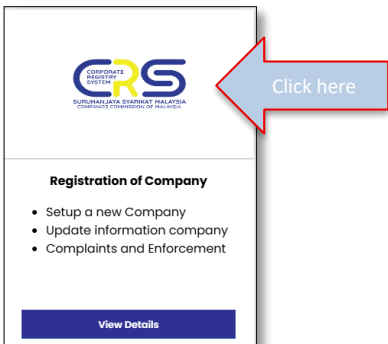
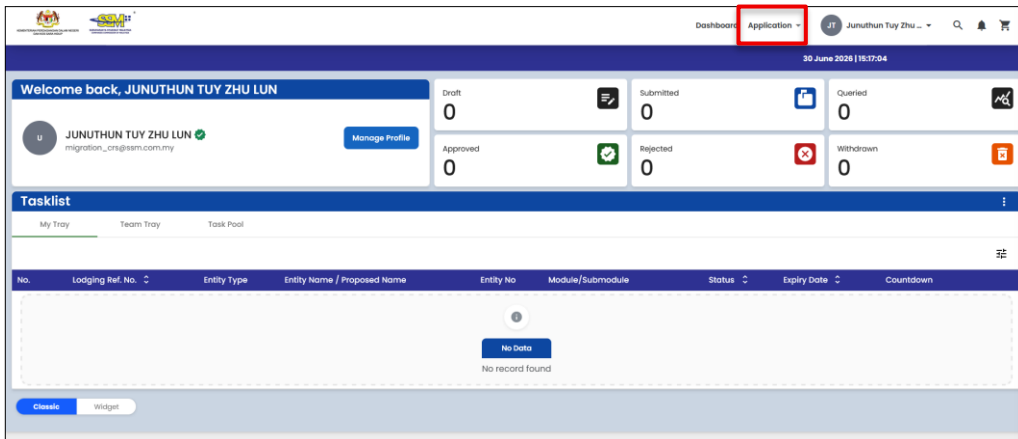
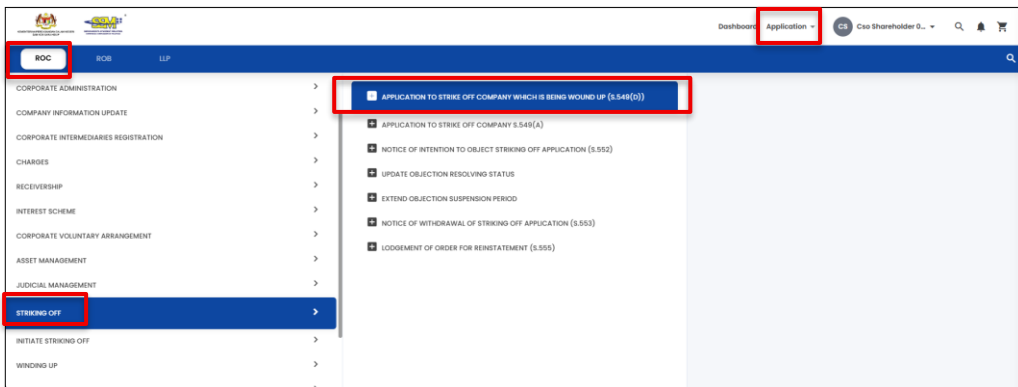
Figure 1: Functional Diagram

3. Common Fields and Definitions

No.	Field	Description
1	Textbox	An input field that allows users to enter and edit text, often used to collect information such as names, passwords, or messages in digital forms and applications. If a textbox has an asterisk (*) next to it, the information is required/mandatory.
2	Radio Button	A set of options where only one can be selected at a time.
3	Checkboxes	Inputs that allow users to select one or more options independently.
4	Search Fields	An input designed for entering search queries to find specific content.
5	Date Picker	An input that allows users to select a date from a calendar interface.
6	File Upload Field	Enter a brief description of the uploaded file to identify its purpose or content. This description helps users and reviewers easily recognize the document during the application review process.
7	Dropdown	A feature that enables individuals to pick a single item from a set of available choices. Upon interaction, the selections appear in a vertical arrangement, allowing one to be chosen.
