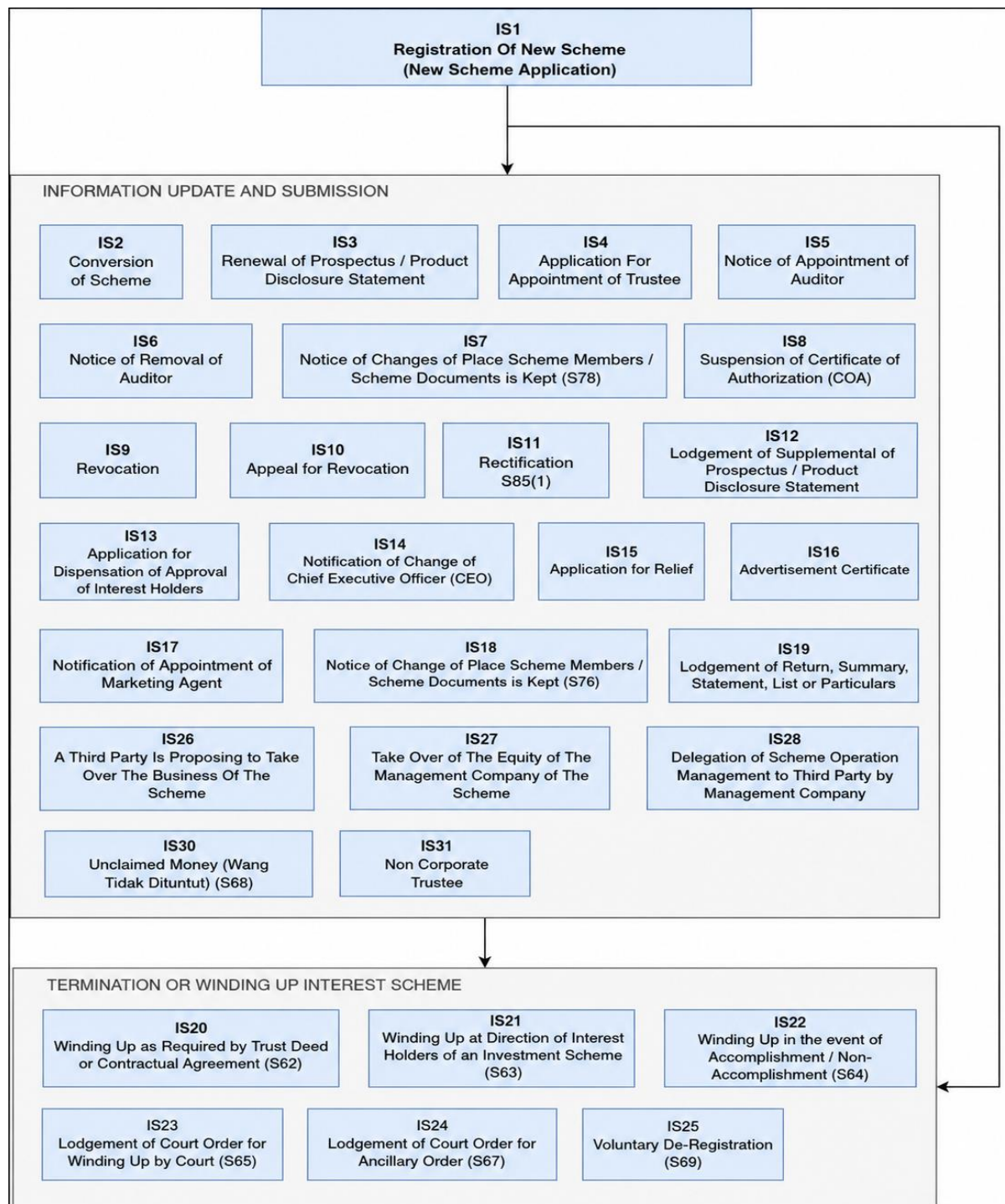
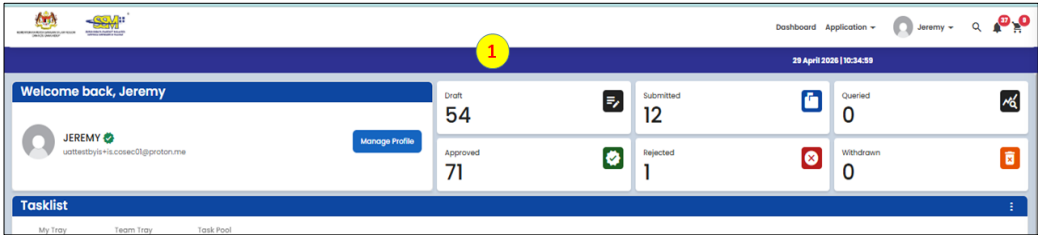
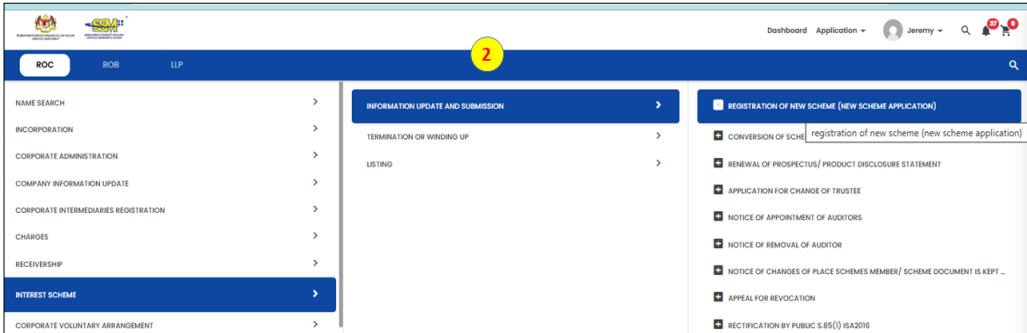
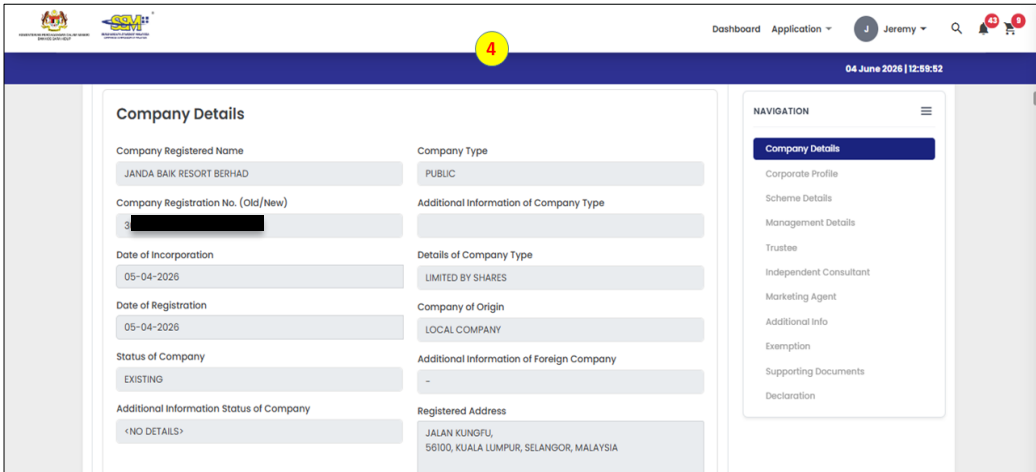


Figure 1: Functional Diagram

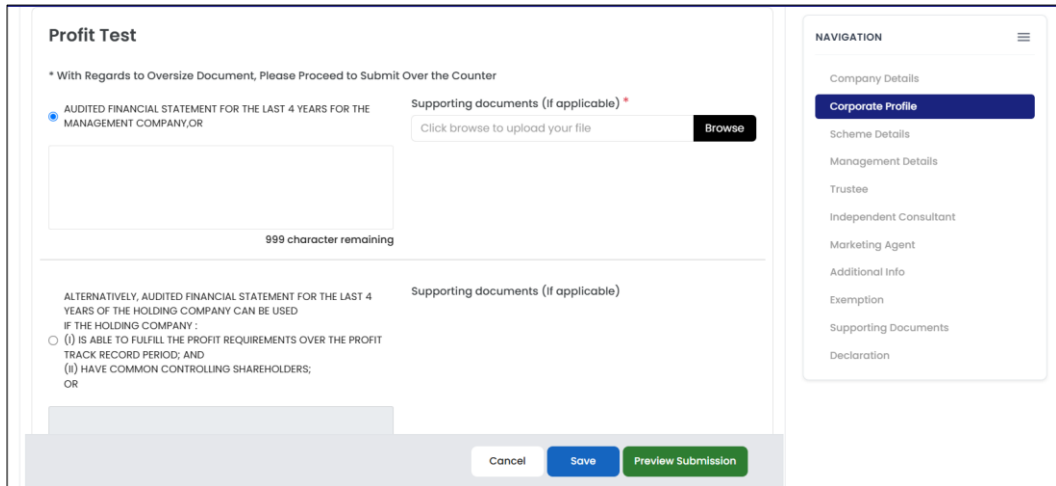
